



Jordan Lions Thanksgiving Arts & Crafts Show 2011



1. Exhibitors – Must set up on Friday October 7, 2011 from 9:00 a.m. to 8:00 p.m. prior to show. This includes tents, displays and shelves and signs. All guide wires must be flagged. No vehicles allowed in show area after 9:00 a.m. October 8,9,10. Show runs from 9 am to 5 pm daily.
2. Each exhibitor must stay within allocated spot as not to intrude on neighbour or obstruct a clear view of other booths. No exceptions. No tear downs or vehicles in show area until after 5:00 p.m. each day.
3. Exhibitors are not allowed to sublet spaces or **tear down displays until the show is over** or the display has been sold out. Exhibitors are responsible for their own tables, chairs and display shelving. No refunds if not available for set up on Friday October 7, 2011.
4. All tents must be fire retardant and should have tags attached stating them to be certified as required by Municipal Fire Prevention office. No open flames in tents. All tents must have fire extinguishers rated for A,B and C types of fires. No bales of straw in tents.
5. There must be someone at each booth at all times and responsible to keep booth clear of garbage and debris during and after show. It is the responsibility of vendor to collect G.S.T. and P.S.T and have vendors permit. Food vendors must comply with the guidelines for outdoor food service and Ontario Regulation 562(R.R.O. 1990). All food vendors will be identified to the Public Health Department Inspection Division, Region/Municipality of Niagara prior to the show. The Jordan Lions Club will not be held responsible legally or otherwise for damage, injury or financial loss, etc. Therefore exhibitors must have their own insurance policy in effect.
6. Liability: The Jordan Lions Club show will not be responsible for any products and for services sold or offered by the vendor. The Jordan Lions Club assumes no responsibility for loses or injuries to property or persons which may be incurred from pilfering, water damage, fire accident or any other cause. No alcohol or pets allowed.
7. All material must be hand crafted and no manufactured goods sold. No soliciting for lessons, no barking, and no hard selling. Vendors of food products must apply to the Niagara Public Health Department Office at 905-688-8245 or 1-800-263-7248
8. The Jordan Lions Club shall not be liable for any loss, damage or injury to any persons or property belonging to or with exhibitors. Exhibitors shall accept total liability for any damage or injury caused as a result of their display and shall hold safe from claim the Jordan Lions Club for any such loss. Jordan Lions Club shall not be held liable for any loss by exhibitor or agent should the show be cancelled for any reason beyond Jordan Lions control, i.e. inclement weather, civil strike or government ruling. Show to continue for next 10 to 15 years, if possible
9. Security provided October 7, 8, and 9, 2011 in evenings. Here's hoping for sun and good weather and see you at the Jordan Lions Community Park.
10. Vendors must have registration in before June 30, 2011, checks made payable to the Jordan Lions Club. No refunds after September 1, 2011.
